Hello and welcome to the December Newsletter – hope you're all feeling festive!

Last month I attended a follow up on the pilot programme for the Animal Health Improvement Cycle (AHIC) – part of the SFS. Since that meeting, alterations have been announced, for example, there are now 12 universal actions rather than 17, although I think this has been achieved by merging rather than omission.

#### Headline alterations include:

- Alterations to the woodland maintenance and hedgerow maintenance actions becoming more achievable and able to fit in to your system
- No longer a blanket 10% tree cover now you are offered support to create a Tree Planting and Hedgerow Creation Opportunity Plan – needing to demonstrate progress by 2030. Far more flexible. May include retrospective planting.
- Animal health and welfare. Few tweaks including anonymity of your data, no need to record antibiotic
  use and lameness prevalence. Also work is being done to try to reduce duplication with other farm
  assurance schemes such as FAWL.

The AHIC pilot project is going well – I think this part of the SFS will really give benefit to farmers. It is very flexible and centres entirely around what you want to improve.

I also went to the Johnes Conference in Worcester – another very interesting day. It was mainly about the National Johne's Management Plan (NJMP) that all our dairy farmers need to do. The overall picture is good – infection levels nationally are now falling after ~8 years of the project – that is certainly the picture in our practice as well.

#### Headlines include:

- The NJMP must be done annually
- The 30 cow targeted screen is now replaced with a 60 random cow screen.

Johne's is such an interesting disease. Eradication is impossible but the disease level can be reduced on every farm by assessing your risks and targeting a few alterations.

All that remains to say is that we all wish you a very Merry Christmas and a Happy and Healthy New Year. See you in 2025, enjoy some deserved time off over the holidays with family and friends.
